The City of Wildwood is at the western edge of the St. Louis metropolitan area, where rapid growth meets steep Ozark topography. Development has eroded creek banks in our nine watersheds. Sewer and water pipes become exposed. Recent flash floods events have closed road and schools.

A Watershed Erosion Task Force (WETF) has been created to propose systemically solutions. Our mission is to protect:

- Public safety ~~(and property?)~~
- ~~Services that are essential to all our residents~~
- ~~Roads, bridges, infrastructure and property threatened by storm water~~
- The natural beauty of our community

Our plans include:

- ~~Surveying the baseline health of our creek beds~~
- ~~Implementing solutions for critical areas that are on public property~~
- Educating Wildwood residents on what they can do to improve the health of our watersheds
- Identifying resources for property owners with erosion problems
- ~~Implementing solutions for critical areas that are on public property~~
- Reviewing city codes to see if revisions could provide better protection for our residents and for the natural beauty of Wildwood
- Developing a storm water management plan
