

RESOLUTION #2019-33

A RESOLUTION BY THE CITY COUNCIL OF THE CITY OF WILDWOOD, MISSOURI AUTHORIZING THE CITY ADMINISTRATOR OF THE CITY OF WILDWOOD, MISSOURI, ON BEHALF OF THIS COMMUNITY, TO AUTHORIZE AND EXECUTE A PURCHASE ORDER WITH GREEN 2GO, L.L.C. FOR THE 2019 WILDWOOD BBQ BASH EVENT (WARDS – ALL).

WHEREAS, on September 27, 28, and 29, 2019 (Friday, Saturday, and Sunday), the City of Wildwood and its partner, St. Louis Home Fires, will again host the Wildwood BBQ Bash Event at the St. Louis Community College – Wildwood Campus venue; and

WHEREAS, this event attracts a great number of attendees from all over the metropolitan area (over 50,000 in total in 2018) and necessitates that certain services be provided at the venue's grounds for its duration; and

WHEREAS, one (1) of these needed services is the provision of electric, security lighting, wiring services, and on-site support for this three (3) day event; and

WHEREAS, the City has obtained a bid from Green 2Go, L.L.C. for the provision of these identified services, at a cost of \$9,000.00, which will address the needs of this event over the described period of time; and

WHEREAS, the cost for this service was anticipated and a comparable amount was set aside, as part of the Department of Planning and Parks' 2019 Operating Budget, when it was acted upon by the City Council; and

WHEREAS, the Department would note that, since the event moved from the Town Center Area by City Hall to the campus of St. Louis Community College, Wildwood has engaged this contractor on an as-need basis, which led to the expenditures of a comparable amount of funds for these necessary and specific services.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF WILDWOOD, MISSOURI, AS FOLLOWS:

Section 1: A Purchase Order, to be executed by the City Administrator, is hereby authorized by the City Council of the City of Wildwood, Missouri, with Green 2Go, L.L.C., 106 Diversified Drive, Villa Ridge, Missouri 63089 for its services at the *2019 Wildwood Barbeque Bash Event* at the St. Louis Community College – Wildwood Campus, based on the proposal herein identified as Attachment B. This contractor already has on file with the City of Wildwood all of the required contracts/agreements and Certificates of Insurance, as part of the City's annual bidding process for public works and parks/planning services.

Section 2: The total expenses and liability of the City under this Purchase Order shall not exceed the contract sum of nine thousand dollars (\$9,000.00).

Section 3: This Resolution shall be effective upon its passage and approval.
