BACKGROUND

The Council formed the *ad hoc* WETF in 2019, and I am pleased to recommend the reappointment of all existing members shown on the attached document and the appointment of two new members representing Ward 1 and Ward 7.

Mr. Alex Bartelsmeyer (Ward 1) is a licensed Missouri architect and current member of our ARB, where he has served our City well.
