

**AN ORDINANCE OF THE CITY OF WILDWOOD, MISSOURI, AUTHORIZING THE MAYOR TO COMPLETE ALL NECESSARY DOCUMENTS FOR THE PURCHASE OF A 2023 CHRYSLER PACIFICA VAN FROM GLENDALE CHRYSLER, DODGE, RAM, JEEP UNDER THE STATE OF MISSOURI'S COOPERATIVE PROCUREMENT PROGRAM FOR THE DEPARTMENTS OF ADMINISTRATION, PLANNING AND PARKS, AND PUBLIC WORKS.**

**WHEREAS**, Section 145.060(E) of the Code of Ordinances of the City of Wildwood (the "Code of Ordinances"), provides that the purchasing requirements established in Chapter 145 of the Code of Ordinances "shall not apply to purchases made through or with the State of Missouri or any other governmental jurisdiction which operate[s] a cooperative procurement program and will allow the City to purchase goods or services that the jurisdiction has made available following the completion of its own internal purchasing procedures[;]" and

**WHEREAS**, the City of Wildwood, Missouri (the "City"), is eligible to purchase vehicles through the State of Missouri Cooperative Procurement Program; and

**WHEREAS**, a fleet vehicle currently utilized by the City has been scheduled for replacement as part of the City's FY-2023 budget; and

**WHEREAS**, through the State of Missouri Cooperative Procurement Program, the City is seeking the purchase of a 2023 Chrysler Pacific Touring Van; and

**WHEREAS**, Glendale Chrysler, Jeep, Dodge, Ram, was the selected bidder under the State of Missouri Cooperative Procurement Program; and

**WHEREAS**, the City Council finds and determines that it is in the best interest of the residents of the City to purchase one (1), 2023 Chrysler Pacific Touring Van from Glendale Chrysler, Jeep, Dodge, Ram, pursuant to the terms and conditions set forth in the Quote, which is attached hereto, marked as **Exhibit A**, and is incorporated by reference herein.

**NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WILDWOOD, MISSOURI, AS FOLLOWS:**

**Section One.** The Mayor is hereby authorized and empowered to purchase, on behalf of the City of Wildwood, Missouri, one (1), 2023 Chrysler Pacific Touring Van (the "Van") from Glendale Chrysler, Jeep, Dodge, Ram, through the State of Missouri Cooperative Procurement Program, pursuant to the terms and conditions set forth in the Quote attached hereto, marked as **Exhibit A**, and incorporated by reference herein (the "Quote").

**Section Two.** That the Mayor is hereby further authorized and directed, on behalf of and in the name of the City, to agree to do any and all other acts and things and to execute and deliver any and all other agreements, documents, instruments and certificates, all as may be necessary and appropriate to consummate the above-mentioned purchase consistent with the Quote. The execution by the Mayor of any agreement, document, instrument, check or certificate referred to in this Ordinance and the Quote shall be conclusive evidence of the approval thereof and of all of

the terms, provisions and conditions contained therein. Any and all acts which the Mayor may do or perform in conformance with the powers conferred upon him by this Ordinance are hereby expressly authorized, approved, ratified and confirmed.

**Section Three.** The total expenditure authorized by this Ordinance shall not exceed \$37,762.38.

**Section Four.** Nothing contained herein shall in any manner be deemed or construed to alter, modify, supersede, supplant or otherwise nullify any other Ordinance of the City or the requirements thereof whether or not relating to or in any manner connected with the subject matter hereof, unless expressly set forth herein.

**Section Five.** If any term, condition, or provision of this Ordinance shall, to any extent, be held to be invalid or unenforceable, the remainder hereof shall be valid in all other respects and continue to be effective and each and every remaining provision hereof shall be valid and shall be enforced to the fullest extent permitted by law, it being the intent of the City Council that it would have enacted this Ordinance without the invalid or unenforceable provisions. In the event of a subsequent change in applicable law so that the provision which had been held invalid is no longer invalid, said provision shall thereupon return to full force and effect without further action by the City and shall thereafter be binding.

**Section Six.** This Ordinance shall be in full force and effect from and after its passage and approval.
